Personal data relating to users (art. 13 Legislative Decree 196/2003).

Dear user, while assuring you that we are available for any further clarification, in regard to the personal data necessary for us to be able to fulfil your requests and in conformity with the Legislative Decree of 30 June 2003, no. 196 (Code regulating the protection of personal data), in particular with articles 13 (Informative) and 23 (Consent), we are supplying you with the following information:

In order to make requests for information it is necessary to register at the following website **www.cdr-mediated.com**. During registration the user will be asked for some personal data.

The data is recorded in a databank and handled according to Article 7 – Code regulating the protection of personal data – Legislative Decree of 30 June 2003, no. 196.

### PURPOSE OF GATHERING AND HANDLING OF PERSONAL DATA

Your data is requested so that we can contact you if any problems occur, send you generic information, and inform you of any updates.

**Subscribers' data is required to be able to supply subscribers with the information requested and to inform them of future commercial offers. The data is not passed on to third parties.**

### RIGHTS OF THE PARTY CONCERNED – THE USER

according to this article, the user has the right to obtain:

- any update, correction, or addition to any data concerning him;
- the cancellation, transformation into an anonymous form, or blocking of personal data handled in violation of the law;
- the party concerned has the right to oppose for legitimate reasons the handling of all or of part of any personal data concerning him, even if it is pertinent to the purpose for which the data was gathered;
- the user has the right to oppose the handling of personal data concerning him for the purpose of sending him advertising material or for direct selling or for the purposes of market research or commercial information;
- confirmation or otherwise of data concerning him, even if he is not yet registered, and their communication in an intelligible form;
